## **NOS for Locksmiths Approved**

The National Occupational Standards (NOS) for Locksmiths have been approved by the regulator UKCES and are available to view on the Skills for Security website. This gives the green light to go ahead with development of a qualification structure and apprenticeship framework for the sector, funded by the Master Locksmiths Association (MLA) and the first meeting to determine what is needed will take place on Friday 6<sup>th</sup> May 10.00 – 12.00 in Worcester.

Working locksmiths, from large and small companies alike, are invited to take part and shape the future of locksmith training nationwide. Ruth Oliver, Skills and Standards Manager at Skills for Security said:

"Locksmiths contributed their knowledge to development of the NOS and we are now asking them to take the next step by telling us what they need in terms of accredited qualifications that will be recognised and trusted across the country. Alongside this work, we are also planning to undertake Labour Market Research into the locksmith sector during June."

Dr Steffan George, Development director for the MLA, said:

"It's great to see the effort put in by a number of MLA members to develop these standards having come to fruition. We look forward to working on the next step which is the development of the qualification itself and then moving on to the end goal of the apprenticeship framework."
