BECOME PART OF 65 YEARS OF HERITAGE

The Master Locksmiths Association was first conceived in 1957 and was the idea of the Chubb Lock Company, and one or two London locksmiths. The prime mover was Mr Steve Fallshaw, then a locksmith in the Barbican, who became its first Chairman when it was formally founded early in 1958.

The original 16 members decided the new 'association' should be known as The Greater London Master Locksmiths Association (GLMLA). By the end of the first decade it had grown nationally with a wide distribution of members from all parts of the UK. At this time, it elected its first national President, namely Mr Steve Stephens of Oxford. The association by now included members from overseas and a healthy growth has been maintained, we now number almost 1500 members in all sectors.

In the early '90s the association restructured to meet modern demands, retaining its title Master Locksmiths Association (MLA) it formed three main sectors: Personal Membership (for individual members wanting personal accreditation), Approved Company Membership (for trading locksmith companies meeting the high criteria stipulated by the association), and Affiliate Members (suppliers to the locksmith industry)

CHAMPIONING THE FUTURE OF LOCKSMITHING

In September 2021 we, supported by Mark Pawsley our local Conservative MP, called for government licensing of the locksmith industry following hundreds of reports from householders who had fallen victim to the unscrupulous activities of those masquerading as locksmiths. The government deemed additional licensing unnecessary due to the Master Locksmiths Association's existing accreditation scheme, which effectively vets, inspects, and qualifies approved locksmiths.

We will continue to raise awareness on this issue and recently appeared in the BBC's Rogue Traders programme as well as Sky News, where we turned focus onto search engines allowing false advertisements.

How QML membership can help you

QML membership can really set you apart from your competitors and increase your professional recognition

- The MLA exam is the highest locksmithing qualification you can achieve in the UK and is the best recognised exam-based proof of competence in the industry being OFQUAL recognised and accredited by ABBE (the awarding body for building regulations)
- QMLs can claim membership, use initials after their name and have use the MLA logo on workwear and business stationery but not on advertising
- Being a QML sets you up for becoming an approved companies or working for an approved company
